**ORDER**

Government have formulated new guidelines for the issuance of NOC for CBSE/ICSE affiliation of schools as per G.O. read as third paper above.

The Kerala Independent Schools Association has represented Government that some schools have already been found eligible by the CBSE/ICSE through an inspection conducted by the CBSE team and has requested the Government to issue NOC to such schools who have already obtained fitness/Eligibility Certificates from respective Boards by 31.10.2011 so as to meet the deadline for registering the students for Board Examinations. Government had examined the matter and decided to issue NOC to those schools also which have already obtained eligibility from the respective Boards subject to them meeting all the conditions read as 3rd paper above.

Government have examined the propsoal in detail and are pleased to issue NOC to the following Schools who have obtained eligibility from respective Board and also satisfies all the norms set by Government as per the G.O. read as third paper above subject to the execution of agreement with Government in the prescribed format.


